Press conference at Parliament puts the spotlight tax fairness

As MPs debated the budget on June 13, Canadians for Tax Fairness held a <u>press conference at</u> <u>Parliament</u> outlining the fair tax alternative to massive cuts in public services and the ongoing denial of new services that Canadians need. The press conference was covered by CBC, CTV, radio and newspapers.

CTF spokesperson Chandra Pasma said "in recent decades the management of public finance has been largely driven by an agenda focused on cutting taxes and shrinking government. Most of our political leaders, either in agreement or because of electoral fear, have played along. Taxes were cut, more loopholes added and – surprise – we're told that the public treasury doesn't have adequate funds for existing programs, let alone others that are needed."

She outlined how reforms to make the tax system fairer and more progressive could generate more than \$84 billion over three years, and provided examples of new public services that could be funded, such as pharmacare, community health care for seniors, low-cost childcare and eco-friendly urban infrastructure.

Chandra was joined at the press conference by David Macdonald, coordinator of the Alternative Federal Budget project of the Canadian Centre for Policy Alternatives, and Joe Gunn, representing Dignity for All, a national anti-poverty campaign supported by 540 organizations.

Canadians for Tax Fairness planning Fair Tax Summit in Ottawa

The CTF board held its first in-person meeting in Ottawa on June 13. The board adopted an ambitious plan for fundraising and actions in the coming six months.

In addition to maintaining an active media relations program and developing popular education materials, CTF is currently contacting potential co-sponsors for a major Fair Tax Summit in Ottawa later in the year. The objective is to bring together academic experts, economists, NGOs, labour, students, activists, politicians and journalists for a comprehensive array of presentations and discussions.

"This is the time to put the political spotlight on the growing concentration of wealth and economic disparities and how a fairer, more progressive tax system could fund the public services we need for a healthy 21st century society," said CTF coordinator Larry Gordon. Further details will be available in September. "

New book in the works

CTF staff and volunteers are pushing forward with another major project - a new book with the working title: "Saving the Canada We Love: Why everything Canadians cherish about our country depends on tax fairness".

The book will feature chapters written by leading experts and journalists, providing a plain language overview of why a more progressive tax system is an urgent priority and what reforms are needed. A detailed book outline will soon be circulated to potential contributors.
